Prior to joining OPR, Debbie served as the Policy Director at the Environmental Justice Coalition for Water, a coalition of more than 70 community-based, tribal, non-profit, and faith based organizations working together to achieve water justice in California. In her role at EJCW she coconvened the California Water Summit, a neutral venue to learn about, discuss, and debate California's water future. Debbie has a Bachelor's Degree from UC Davis and a Master's Degree in Social Ecology from UC Irvine.

Katie Burdick has provided professional consulting services in California and across the country since 1972. Gary Lippner is a registered Civil Engineer with 20 years of experience focusing on infrastructure development and water. Gary was employed at CSU Sacramento's Office of Water Programs where he experienced academic and project management work. He also worked with Contech Construction Products where he experienced infrastructure development across North America. Currently, Gary is a Senior Engineer in DWR's North Central Region Office and manages the Water Supply Evaluations Section that focuses on local assistance, IRWM, and CA Water Plan activities. Gary also acts as NCRO's Regional Coordinator to facilitate the office's support of more than 50 DWR programs and coordination with hundreds of local and regional water agencies.

Shanti is a Miwok woman from the Sierra Nevada Mountains and a member of the Colfax-Todds Valley tribe. As an indigenous person from a riparian people, the protection and restoration of what western ideology calls natural resources is paramount to the survival of California Tribes for the physical and

spiritual well-being and is what she advocates for. She is a strong supporter of California Indians and Indian Communities exercising Self Determination to secure the inherent rights belonging to them in and for their traditional aboriginal territories.
