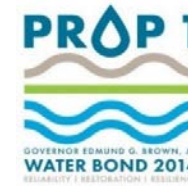

North Coast	North Coast	Grant Award: \$114,860 <i>Total Project Cost: \$137,670</i>	County of Humboldt <i>Mendocino County Resource Conservation District</i>	Water Conservation Technical Assistance to Mendocino County Tribes	This project will provide water audit technical assistance and training to assist Tribal water suppliers to help meet reduced water demand goals that benefit salmonids and Tribal communities.
